The property is set along Anson Road, which is located off Brecknock Road, nearest tube stations being Tufnell Park (Northern line) & Kentish Town (Northern line) and close to Kentish Town Thameslink, local bus services, cafes, shops, Tufnell Park Tavern & Tufnell Park playing fields including its tennis courts. The Kings Cross area is a bus ride away from Brecknock Road, for its amenities including Kings Cross rail stations, St Pancras Eurostar services, the Regents canal, Granary Square & the shops and restaurants of Coal Drops Yard.

The flat comprises a reception room with access to a kitchen, a bathroom and a bedroom with step up to a walk-in storage room/cupboard.

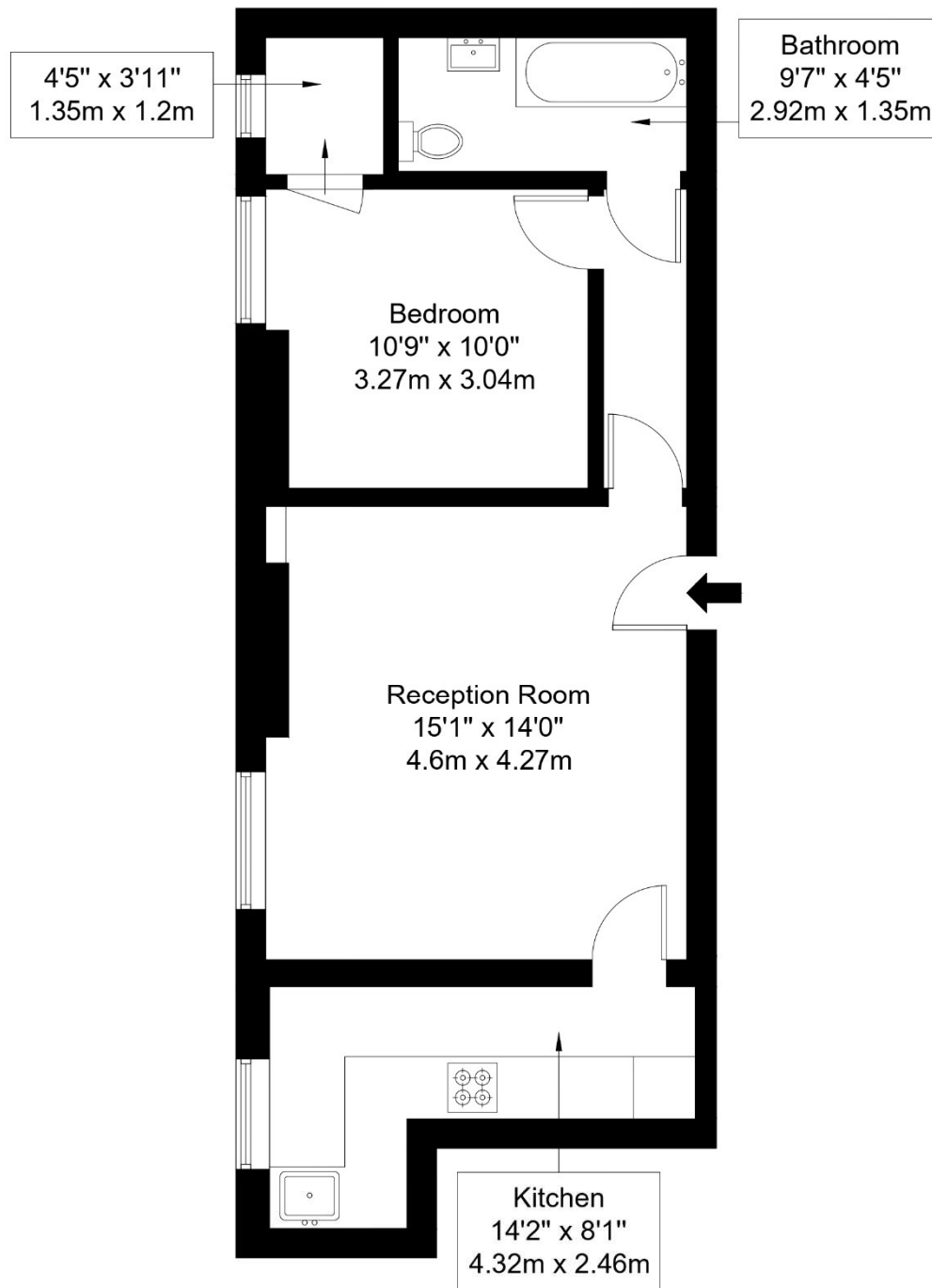
